Effective October 1, 2010, the School Social Work Association of America provides \$250,000 in professional liability and employment liability lawsuits insurance from the **Forrest T. Jones & Company.** to all active employed members (as defined by SSWAA bylaws) who meet the plan's eligibility requirements.

- * In-dues plan covers you for claims that occur, and result in reported claims, during the policy period or after the retroactive coverage date.
- * Defense costs are paid in addition to the limit of liability for legal actions arising from a professional liability claim.

This insurance benefit extends to full members, associate members, student members and part time school social workers. If you are a W-2 employee you are eligible. Coverage does not include self-employed personnel. Retired and International members are also not eligible for this coverage. **Coverage is in force as long as your SSWAA membership is active and current.** If your membership expires, your coverage expires at that same time.

Upgrade to \$1,000,000 Coverage

For only **\$25 more annually**, you can choose to **upgrade your total liability protection to \$1,000,000** which adds valuable job protection benefits.

- * Upgrade adds Job Protection Benefits - legal support if you are subject to a job action such as termination, suspension, reassignment or demotion.
